R. Collver inquired if similar trends of improvement on Term 1 Report Card L3-4 are also seen in EQAO results. B. Blancher explained that on term 2 report card results for Reading last year 64% of our grade 3 students achieved L3-4 compared to EQAO results of 61% whereas 65% of our grade 6 students achieved L3-4 on term 2 report cards but 73% of our grade 6 students achieved L3-4 on EQAO. There are similar trends in Writing. She referred to term 2 last year and compared results of provincial standards met and EQAO results. B. Blancher was optimistic that report cards would reflect improvements in marks.

D. Dean asked for clarification about graphic text selections and information text selections. A. Nesbitt explained an example of graphic text would include a diagram of a football stadium and it would require the student to use a scale, compass, symbols etc. An example of information text would include a manual that describes how to use a device.

- D. Dean inquired about proportional learning and if it leans heavily on multiplication and division. A. Nesbitt agreed that it was asked if a student can effectively reason proportionately if they cannot perform simple math facts in their mind. Balance should include both the ability to reason and problem solve. By grade 10 in the academic stream a student will need to effectively do both or they will have a difficult time having success in grade 11 university stream mathematics.
- D. Dean felt that emphasis on reaching that balance should focus more on the math facts. A. Nesbitt agreed that there has been a discussion related to that issue and there needs to be balance between the memorization and students having the ability to problem solve and reason.
- A. Felsky thanked the team for providing a complex report in a thorough way. She inquired how do we take into account students who may be changing the way they identify. A. Nesbitt explained that we identify the student the same way they would identify themselves.
- J. Forbeck explained that FNMI students are looked at as a subset of students in the BIPSA plan and presented the collaborative inquiry for First Nation Métis Inuit (FNMI). He further explained a marker student and reviewed the following presentation slide:
