### C-1 Director's Report

The Director announced that June is Aboriginal Awareness month in the Grand Erie District School Board, and postcards will be circulated for voluntary aboriginal self-identification.

B. Blancher provided an update on Camp SAIL, which will run at King George this summer for three weeks Monday to Thursday. The literacy program will run in the morning and the YMCA will run the afternoon program featuring activities such as

arts/crafts, mad science and aboriginal group presentations. A parent information night will be held on June 19, 2012.

W. Baker discussed a second literary camp supported through the Learning Environment Branch at the Ministry of Education. It will take place Houghton, with a location to be confirmed. Previous and present Valley Heights Turning Point students will take a leadership role as junior and senior counselors, in the 19 day program starting July 16, 2012.

M. Macdonald highlighted the concept of "Imagination Library", and suggested looking into books for these summer literacy programs.

In response to R. Collver, W. Baker explained the program would focus on grades one through three, and would also provide literacy for any other family members at the camp.

In response to A. Everets, W. Baker confirmed bussing would be provided with the establishment of pick up points.

In response to D. Werden, W. Baker stated that funding came specifically for the Low-German Mennonite community, however is open to all students in grades one through three.

J. Angus requested dates and opportunities for which trustees can visit these programs.

The Director spoke about the Council of Exceptional Children Awards Night and highlighted the many awards present to students, staff members, and parents from Grand Erie District School Board.

# (a) Bylaw 8 - Terms of Reference for the Grand Erie Compensatory Education Steering Committee

J. Forbeck explained the updates to Bylaw 8 with the additional of Terms of Reference for Grand Erie Compensatory Education.

The composition of the committee was reviewed and revisions made.

In response to D. Werden, J. Forbeck explained that the union representative would be selected by EFTO, OSSTF, and CUPE. Parent representatives would be identified by principals.

The initial years would include the Director and/or Superintendent as participants on the committee.

- R. Collver recommended bringing a status report in February to take into consideration the staffing component.
- C. A. Sloat inquired if there is a budget to organize and support events to promote Learning opportunities about compensatory education for leaders and staff of Grand Erie.
- J. Forbeck explained annual learning events would be discussed by the committee.
- J. Forbeck explained the community poverty breakfast meeting will occur on Wednesday June 6, 2012 in Jarvis and discussed how an anti-poverty group in Haldimand Norfolk is in the beginning stages of development.

In response to D. Dean, J. Forbeck recognized the large size of the committee with 25 to 30 members and suggested a facilitation approach in meetings.

- J. Forbeck explained facilitation in a group of 25 committee members would be defined as smaller working groups.
- R. Collver requested the Striking Committee meet to discuss trustee representation on this committee. The Striking Committee comprised of R. Collver, D. Dean, B. Doyle, A. Everets, C.A. Sloat and D. Werden will meet on June 11, 2012 at 6:00 p.m.
