Symposium

I am pleased to follow up on the memo to you from Deputy Minister Bruce Rodrigues and the letter from Honourable Mitzie Hunter, Minister of Education, inviting parent members of your Parent Involvement Committee (PIC) to attend the 8th Annual PIC Symposium. Based on the success of last year and the positive feedback we received, we will once again host six regional symposia and one French-language symposium. This allows us to better respond to local needs and will give more parents the opportunity to participate. You have been copied on the details for your region's symposium from your regional office.

I am writing to invite you (or a designate) to the afternoon portion of the symposium and request your assistance with the travel and accommodation arrangements of your PIC and school council delegates. As in previous years, your district school board's expenses will be reimbursed by the ministry following the event. Your support in encouraging and enabling these parent volunteers to participate in their local symposium is greatly appreciated.

Symposium and Registration Details

The London Regional PIC Symposium will take place on **Saturday, April 1, 2017** from 9:00 a.m. to 4:00 p.m. at the Best Western Plus Stoneridge Inn & Conference Centre, 6675 Burtwistle Ln, London, Ontario. Registration for parent participants will begin at 8:30 a.m. We'd like to invite you to join the symposium at 12:00 p.m. for lunch, followed by an afternoon program which will include a keynote address, dialogue, discussions and a chance to enhance connections with parents through face-to-face dialogue.

Two (2) parent members of your PIC and five (5) parent members of school councils from your district school board, for a total of seven (7) parent participants from your district school board, may register online at: https://pic2017symposiumlondon.eventbrite.ca. The deadline for registration is March 24, 2017. Please note that all participants must be registered in advance of the symposium.

Hotel Arrangements

As in previous years, PIC representatives will be asked to contact their district school board to assist with travel and accommodation arrangements. For the London Regional PIC Symposium, participants who live in excess of 100 kilometres from the Best Western Plus Stoneridge Inn & Conference Centre, 6675 Burtwistle Ln, London, are eligible for hotel accommodation. PIC representatives were also asked to distribute the symposium details and Expense Claim Guidelines to school council parent representatives they are inviting to attend the symposium.

We are pleased to announce that applications for the 2016-17 Parents Reaching Out (PRO) Grants program are now being accepted. We greatly appreciate your leadership and continued support for PRO Grants and for encouraging more parents to be involved in their children's learning.

<u>Achieving Excellence: A Renewed Vision for Education in Ontario (2014)</u> recognizes that parents are a key part of Ontario's success in education. Ontario's PRO Grants support parents in identifying barriers to engagement in their own community and to find local solutions to engage more parents in support of student achievement and well-being.

There are two components to the PRO Grants program:

PRO Grants for School Councils support projects that help identify and remove barriers to parent engagement that may prevent some parents from fully participating in their children's learning. School councils may develop proposals individually, with other school councils or with other groups in their school or community. Each school council may apply for a maximum of \$1,000. To learn more about PRO Grants for school councils, please visit the ministry website at: https://www.edu.gov.on.ca/eng/parents/schools.html.

With your support, we can deepen outreach to schools that have not participated in the PRO Grants program in the past and priority schools in high-needs areas. We appreciate your efforts in communicating the availability and benefits of PRO Grants and encouraging school council participation.

PRO Grants for Regional/Provincial Projects are available to Parent Involvement Committees, district school boards, parent organizations, non-profit organizations and post-secondary institutions working in partnership with parents to support student achievement and well-being. As in previous years, priority will be given to parent-led projects that have been developed in partnership with district school boards. The maximum grant available for regional/provincial projects is \$30,000. This year, special consideration will be given to eligible school council and regional/provincial projects that promote parent support for their children's math learning at home and at school, as well as projects that support engagement of parents in fostering safe, inclusive and accepting schools.

WHAT YOU NEED TO KNOW TO APPLY

Who may apply?

• School councils of publicly-funded district school boards in Ontario.

What types of projects are eligible for funding?

- PRO Grants for School Councils are intended to support projects that help identify and remove barriers to parent engagement that may prevent some parents from fully participating in their children's learning.
- School councils are encouraged to work with their district school board's Parent Involvement Committee and other school councils to identify potential project opportunities.
- School councils may develop proposals individually, with other school councils, or with other groups in the school or in the community.
- When working in partnership with other school councils, each school council must submit its own application. Each school council is eligible for a maximum amount of \$1,000.
- There is an opportunity in the application form to indicate a partnering school.

THINGS TO THINK ABOUT WHEN DEVELOPING YOUR PROPOSAL

Your proposal must focus on informing or engaging parents in support of student achievement and well-being. Projects may fall under the following categories:

- **Communication** may include translation of documents into multiple/other languages, providing parents with information related to curriculum or other school-based initiatives
- **Geography** reaching parents living in a larger or remote geographic area
- Parents New to the System parents who have a child in school for the first time, have recently moved into the area, or have recently arrived as newcomers to Ontario
- Overcoming Local Barriers identifying local barriers to parent engagement and finding local solutions to support more parents get involved
- Other types of barriers

Please ensure that you provide a detailed breakdown of your budget proposal.

THINGS TO THINK ABOUT WHEN DEVELOPING YOUR PROPOSAL

Special consideration will be given to eligible projects from school councils that:

- 1) did not receive funding for 2015-16,
- 2) promote increased access and awareness of math strategies and resources for parents to support their children's learning at home and at school, or
- 3) support engagement of parents in fostering safe, inclusive and accepting schools.

Alignment with provincial priorities, such as:

- Aboriginal Education Strategy/First Nation, Métis, and Inuit Education Policy Framework
- Character Development
- Early Years
- English Language Learners
- Literacy

- Mathematics and Numeracy
- Healthy Schools
- Safe, Inclusive and Accepting Schools
- Special Education
- Student Success/Learning to 18
- 21st Century Teaching and Learning

WHAT YOU NEED TO KNOW - BUDGET

School councils may apply for a maximum grant of \$1,000.

Ineligible Project Costs or Activities

- Activities that have already taken place
- Payment to staff
- Cost of police background check
- Purchase of goods and services for which the Ministry provides funding
- Student-focused activities
- Capital items
- Portable/handheld devices such as tablets or laptops, unless devices are to be used as part of a parent lending library and the cost does not exceed 50% of the approved grant
- Computer software, online subscriptions, voice messaging systems, website maintenance, or software applications

- Entertainment activities
- Art mural projects, field trips
- School signs, announcement boards/screens
- Landscaping, creation or equipping of outdoor classrooms
- Refreshments exceeding 15% of the approved funding
- Advertising and promotion exceeding 5% of the approved funding
- Prizes or incentives to parents and/or students
- Lessons for parents
- Fundraising events

Grant approval is subject to the number of eligible applications received by the Ministry and available funding.

WHAT HAPPENS AFTER I SUBMIT MY APPLICATION?

The grants will be awarded through a provincial review process. Applicants will notified by email about the results of their application.

If approved, school councils will:

- Be responsible for carrying out their project as outlined in the application
- Be required to implement their projects by **June 30, 2017.**
- Be required to complete a final report outlining project activities and expenditures by July 15, 2017.



WHAT YOU NEED TO KNOW TO APPLY

Who may apply?

- Non-profit organizations operating in Ontario
- Parent groups operating in Ontario
- Publicly-funded district school boards operating in Ontario
- Post-secondary institutions in Ontario

What types of projects are eligible for funding?

Projects must enhance parent engagement in support of improved student achievement and well-being and must fall under at least one of the following areas:

- Parents as Partners involve parents as partners in education
- Welcoming District School Board and School Environment for All Parents designed to make all parents feel welcome and included
- Skill-Building Opportunities for Parents provide parents with the knowledge, skills and tools they need to support student learning at home and at school
- Enhancing Communication between School and Parents develop outreach initiatives to support parent engagement in their children's learning

Priority will be given to parent-led projects that have been developed in partnership with district school boards.





THINGS TO THINK ABOUT WHEN DEVELOPING YOUR PROPOSAL

Your proposal must include how the project will:

- Meet a demonstrated need to support parent engagement in support of student achievement and well-being
- Involve parents in the development and implementation
- Promote collaboration between parents, schools and community organizations
- Promote parent leadership and build capacity to engage in their children's learning
- Potentially reach a large number of parents or how it can be adapted to other regions
- Be evaluated

Please ensure that you provide a detailed breakdown of your budget proposal.

THINGS TO THINK ABOUT WHEN DEVELOPING YOUR PROPOSAL

Special consideration will be given to eligible projects that:

- 1) have not been previously funded under the PRO Grants program,
- 2) promote increased access and awareness of math strategies and resources for parents to support their children's learning at home and at school, or
- 3) support engagement of parents in fostering safe, inclusive and accepting schools.

Alignment with provincial priorities, such as:

- Aboriginal Education Strategy/First Nation, Métis, and Inuit Education Policy Framework
- Character Development
- Early Years
- English Language Learners
- Literacy

- Mathematics and Numeracy
- Healthy Schools
- Safe, Inclusive and Accepting Schools
- Special Education
- Student Success/Learning to 18
- 21st Century Teaching and Learning

WHAT YOU NEED TO KNOW - BUDGET

Organizations may apply for a maximum grant of \$30,000.

Ineligible Project Costs or Activities

- Activities that have already taken place
- Payment to staff
- Cost of police background check
- Purchase of goods and services for which the Ministry provides funding
- Student-focused activities
- Computer software, online subscriptions, voice
 messaging systems, website maintenance or software applications
- Capital costs
- Portable/handheld devices such as tablets or laptops
- Refreshments exceeding 15% of the approved funding

- Advertising and promotion costs exceeding
 5% of the approved funding
- Speaker fees or honoraria exceeding 40% of the approved funding (including speakers' travel costs)
- Operational costs
- Purchase of items that would be given to parents which are not directly related to the workshop, seminar or home application to support their children's learning
- Honoraria for parents
- Out of province travel
- Debts or financial losses that result from a project

Grant approval is subject to the number of eligible applications received by the Ministry and available funding.

WHAT HAPPENS AFTER I SUBMIT MY APPLICATION?

- The grants will be awarded through a provincial review process.
- Applicants will notified by email about the results of their application.
- All reporting requirements for previously funded PRO Grant projects must be met prior to funding of 2016-17 projects.

If approved, applicants will:

- Enter into an agreement with the ministry.
- Be required to implement their projects by **August 15, 2017**.
- Be required to complete an interim and final report outlining project activities and expenditures:
 - Interim report is due **February 28, 2017.**
 - Final report is due August 31, 2017.


