- A career coach to help you throughout the program;

- Workshops including personal development, career and postsecondary education (PSE) exploration, financial planning, and successful transitions to PSE
- Career exploration opportunities like job shadowing, sector specific activity days;
- PSE exploration opportunities like personalized visits to college/university campuses and meetings with PSE liaisons; and
- Support in applying to PSE including application fees for OCAS/OUAC and or first year membership to Ontario College of Trades if you have an employer.
