

Intermediate Boys' Basketball Package 2018

FORMAT

- This year will feature two mini-tournaments and a full day tournament for every team. The mini-tournaments will be for practice and skill development, as well as seeding the pools for the final tournament. The final tournament will include all schools placed in three pools. Teams will play in their pools only and the winner will be presented with a pennant. The championship trophy will be awarded to the Pool A winners.
- League play will consist of two mini-tournaments for each division. The Haldimand West Division will play out of Hagersville Secondary School (HSS). The Haldimand East Division will play out of Dunnville Secondary School (DSS). The first mini-tournament will start at 3:30 and end at approximately 5:30. The second mini-tournament will start at 3:30 and end at approximately 4:50. Each team will play one game against every team in their division. The results will determine seeding for the full day tournament at Dunnville Secondary School (DSS). **If there are skill gaps between the divisions consideration will be taken to balance the pools for the year-end tournament. This consideration will be made with coaches.** The final tournament will consist of pooled round-robin and championship games.
- Coaches can set up exhibition games anytime throughout the season; however, the scores do not count towards the league standings unless the convenor has been contacted and informed of the reason. For example, a team has a scheduling conflict and will play the mini-tournament games missed on their own time.

COACH'S RESPONSIBILITIES

- Bring one volunteer who will be asked to ref or help at the score table.
- Bring your own basketballs for warm-ups.
- Bring different coloured pinneys just in case you match colours with the opposite team.
- Email a copy of your roster using the OFSSA scoresheet attached to Shannon Kelly. She will prepare all game sheets for the score tables. shannon.kelly@granderie.ca
- Have players sign the GEDSB 'Fair Play' contract.
- Have an emergency medical kit and contact list for all your players.

SPORTSMANSHIP

- Due to the gap in skill levels between teams in Haldimand, there have been some big blowout victories in the past. It is **strongly** suggested that if your team is winning by twenty points or more that coaches make adjustments to keep the lead, but not embarrass their opponents.

Example tactics include:

- Loosening defense into a tight zone allowing for shots from the outside and unharassed passing and dribbling around the perimeter.
- Sit your starters. Run your offence through some of your weaker players to give them more experience.
- Pass the ball to every player before shooting.
- No fast-breaks or presses of any kind.
- **If a team continues to perform a full court press while up by 20 points one warning will be issued. If they continue, a technical foul will be called against the offending team. This will continue until the full court press ends.**

RULES

MODIFICATIONS to the FIBA rules

Timing

- Two sixteen-minute straight time halves.
- One-minute break between the halves.
- Last minute of game will be stop time.
- Stop time for injury.
- Stop time for time-outs.

Time-Outs

- Time-outs will be granted at the referee's discretion **only on a dead ball**.
- One full timeout (60 seconds) per half, per team, will be allotted.

Back Court Violation

- Back court violations will not be called.
- **If a team is in the lead and they purposefully do not cross half to avoid the defence, they will be considered to be performing an unsportsmanlike action. Similar to the full court press while up by 20 points rule, a team performing this unsportsmanlike action will be given one warning to stop the action. If it continues a technical foul will be issued every time the unsportsmanlike action is performed.**

Tie Break Procedure

- If there is a tie, a five-minute overtime will determine the winner of a game. Only the last minute of the tie-breaker is stop-time.
- If there is a tie in the mini-tournament standings, or group stage of the final tournament standings, the following criteria will determine seeding:
 1. All games from the mini-tournament or round robin for the final tournament will be factored into the math;
 2. The head-to-head result is the first determining factor;
 3. If the teams tied in their head-to-head match or there is a three-way tie, then the team with the least points scored **AGAINST** them at the completion of the mini-tournament or round- robin will advance from the pool.
 4. If there are equal amounts of points scored against the teams tied, points **FOR** them at the completion of the mini-tournament or round- robin will determine who advances from the pool. All games from the mini-tournament or round robin will be factored into the math;
 5. **LASTLY**, if there is still a tie, a coin toss will determine the team that advances. Numbers will be drawn to determine which team(s) will make the call fist. Both coaches and captains must be present at the coin toss. The correct call on the coin will determine the winner. If there is a three-way tie, the coin toss will be carried out in a round-robin fashion with each team tossing a coin against the other. The winner will be the team with the best record after the coin toss round-robin.

Defense

- **Zone defense is allowed.** It is encouraged that you use both man-to-man and zone defense to develop your players. If it is recognized that teams are using zones only and it becomes an issue, this rule will be reviewed.

Scoring

- A field goal counts for two points.
- A free throw counts for one point
- There is no designated “three-point range” on courts.
- Three points will be awarded for a win, two for a tie and one point for a loss for both the mini-tournaments and the final tournament standings.
