Background:

On Monday, October 26, 2020, Trustees approved a motion to the Board to appoint a qualified Trustee to the vacant position. J. Roberto, Director of Education & Secretary prepared a report which included a sample advertisement, application form and critical dates for the process. The posting closed on November 10, 2020. The names of the applicants were forwarded to the County of Brant and Norfolk County. To be qualified, a candidate must be over 18, a public-school Board supporter and live in the geographic jurisdiction of the Grand Erie District School Board.

Timelines for Interviews and Appointment Process:

November 16, 2020	Trustees meet to review applications and decide to create a short
	list or interview all candidates. Interview questions and the
	interview process will be confirmed. Attached is Appendix A – a list
	of applicants.
November 17-18, 2020	Applicants are informed about interview process and provided with
	a pre-question if deemed appropriate by Trustees.
November 25 and/or 26, 2020	Application Interviews and selection.
	Special Board Meeting to follow for the appointment of the
	Trustee.
December 7, 2020	Official start date for the appointed Trustee.

Interview Process:

Interviews will take place in the Joseph Brant Learning Centre (open to the public) on **November 25th and/or 26th 2020** beginning at **5:00 p.m**. Each candidate will have a 20-minute timeframe. Candidates will be greeted upon arrival and sequestered until their interview time.

Confirming Decision-Making Process:

All Trustees are part of the interview. The Director of Education & Secretary will attend the interviews as a resource and will appoint two scrutineers. The process for Trustee consideration involves a series of voting rounds lasting until one candidate receives a majority of votes from the attending Trustee voters. The following process could consist of the following rounds:

- Round One All attending Trustees will receive one ballot to vote for one candidate. Ballots will be tallied by the scrutineers. The applicants with one vote or less will be eliminated from the list and voting will enter round two.
- Round Two The applicant with the least number of votes in round two will be "eliminated" from the list and voting will enter round three.

- Voting will continue until one applicant has a majority of the attending Trustee votes.
- At the conclusion of the process, the scrutineers will destroy all ballots.

Note: In the event of an equality of votes, lots will be applied, as outlined in the Act.

COVID-19 Screening:

Candidates will be required to complete the following COVID-19 protocols:

- All persons attending the interviews are required to complete the School COVID-19 <u>online</u> self-assessment tool.
- All persons attending the interviews must follow the two metre (6 feet) physical distancing rule at all times.
- All persons must practice proper respiratory etiquette.
- All persons are required to wear proper face masks upon building entry.
- All in attendance must perform hand hygiene upon entry and exit.
