In Ontario, the **cost of vaping fines** includes:

- A **\$1,000 fine for the first offense.**
- A **\$5,000 fine for any subsequent offenses.**

These fines apply for vaping in prohibited areas, such as enclosed workplaces, public places, and schools.

In addition, Suspensions may occur for students vaping within 20 meters of campus and any student caught vaping inside the school.
